NOTES:

1. Section 105(2): Requirement of giving a reasonable prominence statement of proxy:

A MEMBER ENTITLED TO ATTEND AND VOTE AT THE ANNUAL GENERAL MEETING (THE "MEETING") IS ENTITLED TO APPOINT A PROXY, WHERE THAT IS ALLOWED, ONE OR MORE PROXIES, TO ATTEND AND VOTE INSTEAD OF HIMSELF, AND THAT A PROXY NEED NOT BE MEMBER.

A person can act as a proxy on behalf of members not exceeding fifty and holding in the aggregate not more than ten percent of the total share capital of the Company carrying voting rights. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as a proxy for any other person or shareholder.

2. Section 105(6): Proxy Form

Proxy Form in the prescribed Form No. MGT-11 is annexed hereto for the appointment of proxy by the members. The Proxy Form in order to be effective should be duly completed and deposited at the registered office of the Company, not less than 48 Hours before the commencement of the meeting.

3. Section 105(8): Requirement of giving three days' notice by a member for inspecting the proxies lodged

Every Member entitled to vote at a meeting of the Company, or on any resolution to be moved in the meeting, shall be entitled to inspect the proxies lodged by giving a not less than 3 days' written notice of his/ her intention of doing the inspection.

4. Section 170: Register of Directors and their shareholding

In accordance with the requirement of the Section 170 of the Companies Act, 2013, registrar of Directors and their shareholding shall be kept open for inspection by the Members and shall also be made accessible to any person attending the Annual General Meeting

5. Section 189: Register of Contracts or arrangements in which directors are interested

In accordance with the requirement of the Section 189 of the Companies Act, 2013, register of Contracts or arrangements in which directors are interested shall be placed the Annual General Meeting and shall also remain open and accessible to any person having right to attend the meeting during the continuance of the said meeting.
